Base Module

The base module includes everything you need to get your site up and running, from design to content.

Product Module

(requires: base module)

Sections include: Product editor, product classes, product manufacturers and product suppliers.

Membership Module

(requires: base module)

The membership module adds membership registration and logon to your website. This can be used to collect information about your visitors, restrict access to elements (pages, files etc), send auto-responders, give membership discounts (with product module) and more!

Sections include: Member list, member groups, member profile, member mailers.

Ecommerce Module

(requires: base module, membership module, product module, SSL Certificate)

The e-commerce module adds shopping cart functionality to your website. Visitors can add products to the shopping cart, save their shopping carts, checkout with many payment and shipping methods, view previous orders, send donations etc. Administration includes order tracking, discounting, coupons, digital and physical goods and much more!

Online payment gateway and merchant account with your bank are required to take CC payments.

Sections include: Order List, Discounts and Coupons, Payment Methods, Shipping Methods.

Newsletter Module (available soon for V2)

(requires: base module)

Import recipient lists from xls/csv or synchronize lists with your membership module. Send as many newsletters as your bandwidth limit allows (upgradeable), create campaigns with newsletter issues that visitors can choose from, track statistics (e.g read duration, open count etc), and complete full compliance checks before sending newsletters to minimize the risk of accidentally spamming your list.

Sections include: Recipient lists, newsletter templates, newsletter campaigns, newsletter issues.

Design Packages are available for your new website, or to change the look of your existing website. Extra time can be spent on your Design Package, and is charged at hourly rates.

All we require is that you provide an idea of a theme you would like, a color scheme and any images you would like included in the template.

Design Package #1

Starter design for new templates or to convert existing designs. Includes up to **4 hours** of design time to create a template to suit your business.

Price: \$200

Design Package #2

Standard design to suit most websites. Includes up to **10 hours** of design time to create a template to suit your business.

Price: \$500

Design Package #3

Premium design for websites that need a high level of polish. Includes up to **20 hours** of design time to create a template to suit your business.

Price: \$950

All design packages include:

- Samples of the new template will be shown to you as images.
- Installation of the template into your Spinsoft Website Builder software.
- Special for new websites: We will prepare up to 6 custom pages with your content – simply supply us with your content in digital format (images, word document etc) and we will setup these pages so that your website is ready to go!

Restrictions on design packages:

- Does not include flash animation.
- Design Packages are only available for Spinsoft Website Builder templates, these prices are on top of your Website Builder License.

Hosting Upgrade Pack #1

Additional storage & bandwidth blocks of 100mb/1gig (disk space / bandwidth) may be purchased at any time. Australian Hosting Servers.

Annual Hosting Fee Increase: \$100/year

Hosting Upgrade Pack #2

Additional storage blocks of 200mb disk space may be purchased at any time. Australian Hosting Servers.

Annual Hosting Fee Increase: \$100/year

Hosting Upgrade Pack #3

Additional bandwidth blocks of 2gig may be purchased at any time. Australian Hosting Servers.

SSL Certificate

Highly recommended for the membership module and required for the e-commerce module this SSL certificate will encrypt the data sent to the server on certain pages. More expensive SSL Certificates are available on request.

Annual Certificate Fee: \$150/year

Content Updates or Additional Training (only with Spinsoft Website Builder)

We can update your website content at this special hourly rate if you have a Spinsoft Website Builder License. This rate is not available for custom websites.

Rate: \$65/hour

Custom Programming or Flash Animation

Domains (.com.au .net.au)

Australian domains must be registered in 2 Year blocks.

Domains (.com .net .info)

Most domains can be registered per year. Other domain types are available on request.
